Message from the Minister of Nova Scotia Environment

I am pleased to present the Business Plan for Nova Scotia Environment (NSE) for the fiscal year 2016-2017.

The plan outlines NSE's expanded mandate, shows how it links to government's priorities and provides examples of priority projects under NSE's core responsibilities and services.

Government expanded NSE's mandate in 2015 by consolidating the regulatory compliance, inspection, and enforcement functions from the Departments of Agriculture, Fisheries and Aguaculture, Health

and Wellness, and Natural Resources within NSE. To achieve this broader mandate, in 2016 NSE will implement a new organizational structure and work with its partner departments for improved protection of our environment/natural resources, human and animal health.

Working with the Office of Regulatory and Service Effectiveness, in 2016-2017, NSE will continue its work to review and modernize environmental regulations. We will focus on areas of greatest impact on the environment and public health, help reduce administrative burden, offer on-line services to clients for notifications and approvals processing, and support program management and delivery, while ensuring protection of the environment and public health.

Many of NSE's core responsibilities for protecting the environment and human health are contained in the Environmental Goals and Sustainable Prosperity Act. This Act is closely linked to economic outcomes through its 25 goals and the long-term objective of the Province to achieve sustainable prosperity. A priority for 2016 will be to initiate the second five-year review of the Act.

Other priorities for NSE for 2016-2017 include working with other departments to support a green economy, protecting additional land, reducing Nova Scotia's greenhouse gas emissions and preparing for the impacts of climate change.

We will continue to collaborate with other departments, municipalities, and stakeholders to deliver on our mandate of protecting the environment and human health, while supporting the growth of our economy for Nova Scotians.

MANDATE

Nova Scotia Environment's (NSE) mandate expanded in 2015 through the transfer of compliance, inspection and enforcement responsibilities, and associated staff from the departments of Health and Wellness, Agriculture, Aquaculture and Fisheries, and Natural Resources.

NSE's mandate is to:

- Support and promote the protection, enhancement and prudent use of the environment through strong regulatory frameworks and compliance programs, including education.
- Provide a strong regulatory framework and enforcement mechanisms to ensure a safe food supply for all Nova Scotians.
- Work with others to understand how the environment affects health and act together with our partners, stakeholders and communities to protect health and promote health supportive environments.
- Ensure compliance with appropriate acts to ensure those buying, processing or selling fish have the appropriate license to do so and to ensure aquaculture sites are operating in compliance with the regulations.
- Provide for the establishment, management, protection and use of wilderness areas.
- Provide for the preservation, protection and study of ecological sites that are considered important parts of the natural heritage of the Province and promote understanding and appreciation of same among the people of the Province.
- Improve the quality of life in Nova Scotia, in cooperation with communities, by protecting, conserving and enhancing our natural resources.
- Deliver compliance and enforcement services to ensure the sustainable use of Nova Scotia's natural resources.

- Support the use and enjoyment of the outdoors in a way that minimizes risks to the environment.
- Promote the interconnections between the health of the economy, the environment and the
 people of the Province, and promote the Province's environmental assets as essential to the
 long-term prosperity of the Province.

NSE will implement a new organizational structure in 2016 to achieve our broader mandate. Combining compliance, inspection and enforcement will lead to improved protection of our environment/natural resources, human and animal health.

In 2015, NSE revised its vision to capture its expanded mandate. The vision is:

A leader in regulatory excellence, conservation, partnership and promotion, we protect the environment, human health and animal health.

LINK TO GOVERNMENT PRIORITIES

There are two key objectives of the department that support and contribute to government's key priorities of "People, Innovation and Education."

Protecting Health (People)

With the transfer of the Environmental Health Division from the Department of Health and Wellness, and the Food Protection and Enforcement Division from the Department of Agriculture, NSE has significantly expanded its responsibilities for protecting the health of Nova Scotians.

Collectively, our work in health and environmental protection is aimed at reducing chemical, biological and physical risks, and creating supportive environments to promote a healthy population.

Actions

- 1. Work with departments to coordinate provincial efforts to ensure Nova Scotia meets its commitments to reduce greenhouse gases and prepare for impacts of climate change.
- 2. Work with emitters to reduce emissions that contribute to the formation of ground-level ozone and particulate matter, as well as to maintain the provincial ambient air monitoring network to measure and report on achievement.
- 3. Focus on continuous improvement to drinking water programs.
- 4. Implement the Safe Body Art inspection program in support of the Act and Regulations.
- 5. Focus on continuous improvement within the provincial food safety programs.
- 6. Enforce the province's aquaculture regulations.

Regulatory Excellence (Innovation)

During the past three years, the department reviewed and modernized environmental regulations. Elements of this work included:

- Focusing on risk to ensure programs are focused on areas of greatest impact to the environment and public health.
- Reducing administrative burden to business and improving support provided to municipalities.
- Using technology to support improved program management and delivery.

CORE RESPONSIBILITIES/SERVICES

NSE's core responsibilities are reflected and embedded in its mandate of protecting the environment, human health and animal health through:

- Regulatory excellence
- Compliance, inspection and enforcement
 - Environment/Natural Resources (land, air, water)
 - Food protection
 - Animal welfare
 - Public health
 - Fish processing, buying and aquaculture
- Gathering and understanding evidence, using science
- Education, outreach and transparency
- Approvals, permits, licenses and notifications
- Sharing information on environmental and health risks
- Programs/services that include:
 - Air Quality monitoring and reporting
 - Climate Change (includes adaptation and mitigation)
 - Contaminated Sites
 - Drinking Water, Water Resources
 - Water and wastewater treatment facilities
 - Protected Areas
 - Solid Waste

While carrying out its mandate and core responsibilities, NSE will focus on three priorities for fiscal 2016-2017 that are important to Nova Scotians:

- 1. *Environmental Goals and Sustainable Prosperity Act* (EGSPA)/Green Economy: Continue to work towards achieving EGSPA goals and long-term objective, including coordinating reporting across departments.
- 2. **Consolidation**: Continue the consolidation of compliance, inspection and enforcement programs. This will include workforce planning and implementation of a compliance model and risk based approach.
- 3. **Protected Areas**: The EGSPA goal has been achieved with over 12 per cent of the land mass legally protected. NSE will work with the Department of Natural Resources to achieve

13 per cent protected lands, primarily through the addition of parcels of land with no negative recreational or economic effects. NSE will also focus on implementing a management planning framework for protected lands.

EGSPA and the Green Economy

NSE will continue to work towards achieving the goals established in EGSPA. The Act encompasses many of the department's core responsibilities of protecting the environment and human health, and is also closely linked to economic outcomes. The Act contains 25 goals to support the environment and economy and involves a number of departments in meeting its commitments and vision.

The Minister of Environment is responsible for administering EGSPA and is required to report annually to the House of Assembly on the progress made toward achieving the goals. The Minister is also required to have a review of the Act conducted every five years.

Among EGSPA's goals is the commitment to advance a strategy for growth of the green economy. NSE will work with the Department of Business in support of a greener economy.

Consolidation

Following government's decision to consolidate key compliance activities within NSE effective July 1, 2015, NSE has worked with its partner Departments of Health and Wellness, Agriculture, Fisheries and Aquaculture, and Natural Resources to ensure the effective transfer of staff and resources. In 2016, a new organizational structure will be implemented to align resources for the most consistent, effective and efficient delivery of our programs and services. Consolidated models for compliance, inspection and enforcement will be developed.

Protected Areas

Along with protecting additional land, in 2016, NSE will begin to shift its focus to the management of protected areas to ensure the protection of the environment while supporting the delivery of social and economic benefits. This work will be guided by a new management and planning framework that will help focus the application of resources and decision-making towards areas of highest environmental or public safety risk, as well as wilderness areas with the greatest potential for recreation and tourism development.
