Order dated January 2, 2001
made under Section 13 of the
Dairy Commission Act

THE NOVA SCOTIA DAIRY COMMISSION, pursuant to Section 13 of Chapter 117 of the Revised Statutes of Nova Scotia, the *Dairy Commission Act*, on January 2, 2001

HEREBY ORDERS that ~~Section of~~ Schedule 9 - "Schedule of Milk Prices For Specified Areas" made on ~~August 29, 1989~~ [December 3, 1997] is amended by repealing Section 1 and substituting the following, effective February 1, 2001.

1 Prices paid by processors shall be the following on an F.O.B. Plant basis

Revocation Order re Irving Oil Limited

Revocation Order dated January 10, 2001
made under clause 131(1)(b) of the
Environment Act

D.E.L. 01-01

IN THE MATTER OF clause 131(1)(b) of Chapter 1 of the Acts of 1994-95, the *Environment Act*

- and -

IN THE MATTER OF the revocation of a Ministerial Order issued pursuant to the provisions of the *Environment Act* to **GEORGE B. EL-KHAWAJA** (also known as **GEORGE KHAWAJA**) of Bayside, Halifax Regional Municipality, Province of Nova Scotia; **A & H TRADING LIMITED**, a body corporate, **AHMAD ALFADLY** of Bayside, Halifax Regional Municipality and **IRVING OIL LIMITED**, a body corporate

REVOCATION ORDER

WHEREAS by Ministerial Order issued pursuant to subsection 125(1) of the *Environment Act* dated December 19, 1997, signed by the Minister of the Environment, the Honourable Wayne F. Adams, and duly filed in the Office of the Registrar of Regulations on December 23, 1997, (N.S. Reg. 170/97) and published in the Royal Gazette Part II, Volume 22, Number 2 on January 16, 1998, from page 77-80, the persons named in the Ministerial Order were ordered to comply with the conditions set forth in Schedule "A" attached to the Ministerial Order respecting hydrocarbon contamination at the former service station operated under the name of "Bayside Irving" which is located at or near Bayside, Halifax Regional Municipality, Province of Nova Scotia hereafter called the "Site";

AND WHEREAS the Honourable Acting Minister of Environment and Labour wishes to revoke the aforesaid Ministerial Order with respect to Irving Oil Limited while maintaining the authority to issue further Ministerial Orders in future against Irving Oil Limited if the circumstances so merit;

IT IS HEREBY ORDERED that upon service of this Revocation Order, the Ministerial Order dated December 19, 1997 is revoked with respect to Irving Oil Limited and is of no further force or effect with respect to Irving Oil Limited;

FOR GREATER CERTAINTY, this Revocation Order applies only to Irving Oil Limited and not to the other parties named in the December 19, 1997 Ministerial Order.
