A PROCLAMATION

WHEREAS in and by Section 4 of Chapter 18 of the Acts of 1994-95, An Act to Amend Chapter 450 of the Revised Statutes, 1989, the Summary Proceedings Act, it is enacted as follows:

4 Sections 2 and 3 come into force on and not before such day as the Governor in Council orders and declares by proclamation.

AND WHEREAS it is deemed expedient that Section 3 of Chapter 18 of the Acts of 1994-95, An Act to Amend Chapter 450 of the Revised Statutes, 1989, the Summary Proceedings Act, come into force on and not before April 15, 2002;

NOW KNOW YE THAT WE, by and with the advice of the Executive Council of Nova Scotia, do by this Our Proclamation order and declare that Section 3 of Chapter 18 of the Acts of 1994-95, *An Act to Amend Chapter 450 of the Revised Statutes, 1989, the Summary Proceedings Act*, come into force on and not before April 15, 2002, of which all persons concerned are to take notice and govern themselves accordingly.

ORDER

WHEREAS the Town of Amherst applied to the Nova Scotia Utility and Review Board for a change in its boundary with the Municipality of the County of Cumberland;

AND WHEREAS the Municipality of the County of Cumberland advised the Board that it agreed to the application to change the mutual boundary;

AND WHEREAS Notice of the Proposed Change to the Town Boundary was advertised in the **Amherst Daily News**, a newspaper circulating in the area, on March 1, 2002 and March 5, 2002 and the advertisement invited objectors to advise the Board of their objections;

AND WHEREAS there have been no objections to the application received by the Board to the agreed change to the mutual boundary;

IT IS HEREBY ORDERED pursuant to Section 357 of the Municipal Government Act that the Board confirms the change to the mutual boundary between the Town of Amherst and the Municipality of the County of Cumberland by adding the following area to the Town:

three lots containing 4.75 acres (1.92 hectares) including lots known as PID 25044215 and PID 25043969 (being known locally as the property of the former Logan Eggs Limited) and another lot known as PID 25247586 (known locally as Lot No. 60 on the industrial park map). The subject property is located on the southerly side of Victoria Street West in West Amherst, County of Cumberland, Nova Scotia

IT IS FURTHER ORDERED that the amended mutual boundary is described in Schedule "A", attached hereto and forming part of this Order.

SCHEDULE 'A'

Description of a portion of the Municipal Boundary between the Town of Amherst and the Municipality of the County of Cumberland, approved April 3, 2002.

[Bearings in the following are oriented to the Nova Scotia Co-ordinate Grid 3° MTM Zone 5 Central Meridian 64°30' West Longitude]

BEGINNING at point "A" shown on the attached sketch, being a survey marker found at the intersection of the southwesterly boundary of Tupper Boulevard and the Existing Municipal Boundary;

THENCE S54°42'12"W a distance of 553.74 feet (168.780 metres) along the said Municipal Boundary, being the division line between Lot 60 and a 50 foot wide Town of Amherst Service Easement in the Amherst Area Industrial Park, to a survey marker:

THENCE S54°33'42"W a distance of 252.68 feet (77.017 metres) continuing along the said Municipal Boundary, being the division line between Lot B1, lands of the Nova Scotia Business Development Corporation and the said Town of Amherst Service Easement, to a survey marker;

<u>THENCE</u> N38°12'42"W a distance of 150.00 feet (45.72 metres) along the division line between Lots B1 and B2, lands of the Nova Scotia Business Development Corporation to a survey marker;

<u>THENCE</u> N37°02'11"W a distance of 375.50 feet (114.451 metres) along the division line between lands of Harold and Eileen Lusby described in Book 612 at Page 453, and Lot #2, lands of Logan Eggs Limited, described in Book 631 Page 437, to a survey marker;

<u>THENCE</u> N28°58'21"W a distance of 130.00 feet (39.624 metres) along the division line between the said lands of Harold and Eileen Lusby and Lot #1 of the said lands of Logan Eggs Limited, to a survey marker;


<u>THENCE</u> S58°46'39"W a distance of 222.72 feet (67.885 metres) along the southerly bounds of Victoria Street West to a survey marker;

<u>THENCE</u> S17°50'33E a distance of 455.60 feet (138.866 metres) along the easterly bounds of the Trans-Canada Highway Interchange to a survey marker;

THENCE S37°07'00"E a distance of 236.83 feet (72.185 metres) along the division line between the aforesaid Lot #2 of Logan Eggs Limited and lands conveyed by Herrick Anthony to Roger McInnis recorded in Book 369 at Page 218 and between the aforesaid Lot B2, lands of the Nova Scotia Business Development Corporation and the said lands of Roger McInnis, to a survey marker;

THENCE S37°18'17"E a distance of 923.98 feet (281.629 metres) along the Municipal Boundary, being the division line between the Amherst Area Industrial Park and the said lands of Roger B. McInnis to a Begin of Curve on the southwesterly boundary of Tantramar Crescent, being shown as Point "B" on the attached sketch.
