Schedule "A"

**Amendment to the Dairy Farmers of Nova Scotia By-Laws
made by the Dairy Farmers of Nova Scotia
pursuant to clause 15(1)(h) of Chapter 24 of the Acts of 2000, the *Dairy Industry Act***

- 1 Section 45 of the Dairy Farmers of Nova Scotia By-Laws made by the Dairy Farmers of Nova Scotia and approved by the Natural Products Marketing Council on May 24, 2001, is amended by repealing subsection (1) and substituting the following:
 - (1) In this Section, a designate may be a spouse, parent, son or daughter of a member and must be 18 years of age or over.
- 2 Subsection 45(2) is repealed and the following substituted:
 - (2) Within each region there shall be a milk committee comprised of 4 members or designates resident within the region, who shall be elected by the members resident within the region.
- 3 Subsection 45(3) is amended by striking out "this" and substituting "the" and by adding "of subsection (2)," immediately after "purpose".
- 4 Subsection 45(5) is amended by striking out "ever" and is further amended by adding "or designate" immediately after "member" in the phrase "appoint a member".

**Regulations Respecting Voting Members
made by the Minister of Health pursuant to Section 84
of Chapter 6 of the Acts of 2000, the *Health Authorities Act***

- 1 These regulations may be cited as the *District Health Authority Voting Members Regulations*.
- 2 Further to subsection 13(3) of the *Health Authorities Act*, the Capital District Health Authority may have 4 voting members on the board of directors who hold office or employment in the service of the authority or any hospital or service operated by the authority or who have privileges at any hospital in the health district.

Small Claims Court Forms and Procedures Regulations

Order in Council 2003-308 dated July 4, 2003
Amendment to regulations made by the Governor in Council
pursuant to Section 33 of the *Small Claims Court Act*

The Governor in Council on the report and recommendation of the Minister of Justice dated June 3, 2003, and pursuant to Section 33 of Chapter 430 of the Revised Statutes of Nova Scotia, 1989, the *Small Claims Court Act*, is pleased, effective July 4, 2003, to amend the regulations respecting Small Claims Court forms and procedures made by Governor in Council by Order in Council 93-110 dated February 2, 1993, by adding the following subsection immediately after subsection 18(2):

- (3) The fee payable to the sheriff for an order for the sheriff to deliver possession of property pursuant to Section 3 of the *Small Claims Court Residential Tenancies Appeal Regulations* made under the *Small Claims Court Act* shall be the fee as set out in Schedule "B" of the regulations respecting fees and allowances made under the *Costs and Fees Act*, but shall not in any case exceed \$150.

AND WE, being desirous and resolved as soon as may be to meet Our People of Our Province of Nova Scotia, and to have their advice in General Assembly, do hereby make known Our Royal Will and Pleasure to call a General Assembly, and do hereby further declare that by and with the advice of Our said Executive Council, We have this day given orders for the issuing of Our Writs in due form for the election of Members to serve in

the House of Assembly for the several Electoral Districts of the Province, which Writs are to bear date the 5th day of July, 2003, and the date of ordinary polling day to be Tuesday, the 5th day of August, 2003.
