They are geared toward farmers who need help developing, implementing and maintaining a basic on-farm food safety program that is cost-effective and practical. It is a great way to show customers due diligence in this area.

Crop Insurance

Application Deadlines 2011:

Spring Grain - March 14

Vegetable - March 14

Potato - April 19

Corn, Soybean (*includes canola and sunflowers*) - April 30

Maple - April 30

Weather Plan - April 30

Producers holding an active contract of insurance in one or more of the above plans will receive a coverage quote form(s) before the beginning of the crop year. This will give producers an opportunity to choose their price and coverage level options for the upcoming growing season.

Advanced Payments Program - Reminder

If you are planning to apply for an advance through the Advance Payments Program (APP), please keep the above application deadlines in mind. In many cases, the APP requires participation in Crop Insurance (or CAIS) as a security for the advance. Late applications for crop insurance cannot be accepted after the above dates.

Dairy Producers

The Crop and Livestock Insurance Commission is able to write new coverage for dairy livestock each month. If you are not currently enrolled but would like to be, please call our office. If you are interested in insuring your animals against disease, lost income from milk sales as a result of disease, or fire and building collapse due to ice and snow - it is not too late to apply for dairy insurance (includes all reportable diseases except BSF and Foot and Mouth, along with shipping fever and IBR). Weather Plan for Forage

This plan targets crop losses related to weather events. It guarantees 80 per cent of the average long term rainfall (mm) at a designated local weather station over a period of time (May 1 to August 31). An optional Quality Rider is also available for excessive rainfall in June during prime harvest time. Managed pastures and stored forage acreage can be insured.

Wildlife Compensation

The wildlife compensation program is for farmers who experience losses to animals or crops as a result of uncontrollable wildlife. This program applies to specific livestock as a result of predation by specified wildlife. Similarly, specified crops are covered for losses as a result of wildlife damage. There are a number of requirements to be eligible for this program. For complete details, including prices paid for losses and crop and livestock covered, visit our website at www.gov.ns.ca/agri/ci.

Maple Producers

Crop insurance is now available for maple syrup production. This new plan helps all commercial maple producers manage the risk of reduced yields due to natural perils. Any producers not currently signed up in the program can apply now for coverage for the 2011-12 crop year (the Feb to Mar 2012 harvest season). The deadline for applying is April 30, 2011. Since this is a busy time in the maple woods we encourage you to apply now to avoid missing the deadline.

Forage Producers

The forage establishment plan protects against establishment failure in the first year of growth for grasses, alfalfa and other legumes. This plan covers losses from such things as winter injury, drought, insects, diseases, floods, excess moisture, frost and wind. The plan covers new forage crop from the time of seeding up until May 31 of the following year. Seeding must be completed by

July 1 for legumes and legume/grass mixes and by September 1 for grasses. The deadline to apply for this insurance is October 15, but you can apply as soon as your crop is seeded.

The weather derivative plan for forage provides a guarantee of 80 per cent of the long term average rainfall (30 year average). A producer can choose two, three or four months of drought coverage between May 1 and August 31. Any part or all of the managed forage and/or pasture on your farm can be insured for up to \$288 per acre. An optional quality rider can be purchased for the month of June. When three consecutive days of rainfall of at least five mm are recorded, a payment of 20 per cent of your guarantee is triggered. Producers can receive up to two payments under this quality rider during the month of June. For the weather plan, rainfall measurements are based on the recorded rainfall from sites around the province, primarily at Environment Canada weather stations. Producers select the site nearest their farm. This plan differs from other insurance plans since there are no yield measurements required. Once a drought or excess rainfall event occurs a payment is triggered.

Both the weather derivative plan for forage and the forage establishment plans require an annual application. For more information including the cost sharing with government for these programs contact one of our offices.

Wild Blueberry

Celebrates 15 Years As Province's Choice



Nova Scotia's wild blueberry, worth \$40 million in export sales to 30 countries, is celebrating its 15th anniversary as the province's official berry.

An event held on Feb. 1, at the Seaport Farmers' Market, Halifax, spotlighted its value to the province and its many healthy attributes.

"Wild blueberries are the number one fruit crop in size and export sales in Nova Scotia," said Agriculture Minister John MacDonell. "We're very proud to support a homegrown product that contributes greatly to our economy and provides jobs for more than 3,000 Nova Scotians who are either directly or indirectly employed by the industry."

Proclaimed the provincial berry on Jan. 11, 1996, the wild blueberry is often touted for its medicinal benefits.

"Early research suggested the antioxidant power of blueberries was responsible for health benefits," said Wilhelmina Kalt, research scientist, Agriculture and Agri-Food Canada, who is investigating the berry's health attributes. "More recently, research indicates blueberries may be important in reducing inflammation that comes with disease and aging."

Health research is examining the blueberry's benefits in areas such as cardiovascular health, neuroscience, cancer, inflammation, aging and, more recently, diabetes and sight.

"Nova Scotia wild blueberries go to more than 30 countries around the world," said John Quinn, president, Wild Blueberry Producers Association of Nova Scotia. "We are exploring new markets and new opportunities for the wild blueberry. This is an industry that has growth potential far beyond our borders."

Hosted by the Wild Blueberry Producers Association of Nova Scotia and supported by Select Nova Scotia, the event featured remarks by Mr. MacDonell, Nova Scotia songstress Rosalee Peppard, singing The Nova Scotia Wild Blueberry Blues and children's author Paddy Muir, who wrote Wild Ones to educate youth about the wild blueberry.

Programs and Business Risk Management

AgriInvest and AgriStability

AgriInvest and AgriStability are business risk management programs that help producers protect their income and manage risks like drought, flooding, low prices and increased input costs.

AgriInvest provides farmers with flexible coverage for small income declines as well as support for investments to mitigate risks or improve market income. Farmers deposit money into an AgriInvest account and receive matching government contributions. If you receive an AgriInvest deposit notice you have 90 days to respond by making your deposit.

2009 AgriInvest Deposit Notices

AgriInvest deposit notices have been mailed out with information on how to make your 2009 deposit. Once you receive your deposit notice, you can open an account at your financial institution and make the 2009 AgriInvest deposit by the deadline indicated to receive a matching contribution from governments. Existing funds currently held by the federal government will be transferred to your AgriInvest account. Producers can request a withdrawal from their AgriInvest account through their financial institution at any time throughout the year.

AgriStability is a margin-based program that provides support when a farmer experiences larger farm income losses. AgriStability covers declines of more than 15 per cent in a farmer's average income from previous years. If you participated in AgriStability 2009

you will automatically be enrolled for 2010 and will be receiving a 2010 enrolment notice soon. If you have not received your 2010 enrollment notice and have not heard from AgriStability you should contact the number below.

New Participants or Farmers - AgriStability 2010 Enrolment

Producers who did not participate in 2010 AgriStability and wish to participate in 2011 must request a new participant package before April 30, 2011. To request your package or for more information, visit <http://www.agr.gc.ca/AgriStability> or call AgriStability toll free at 1-866-367-8506.

AgriStability 2010 Interim Applications Are Available

The interim application is available for producers who would like to apply for an advance for the 2010 program year. As a program participant, you cannot receive your full 2010 AgriStability payment until your 2010 program year is complete. By using the interim application, you can estimate your 2010 income and expenses and receive a portion of this payment early. The deadline to apply for the interim is March 31, 2011.

AgriStability/AgriInvest 2009 harmonized form final deadline

If you missed the September 30, 2010 deadline, the final deadline was December 31, 2010 with a \$500/month reduction to your payment.

AgriStability 2010 final fee deadline

You will be ineligible to participate in AgriStability for the 2010 program year if the final December 31, 2010 deadline was missed.

Exciting Changes at Nova Scotia Agricultural College

The year 2010 was extraordinary and historic for the Nova Scotia Agricultural College. We are poised to become a free-standing post-secondary institution in April 2011. This transition will allow us to be competitive in the post-secondary market and is the first but significant step in transforming the college a more vibrant, competitive and responsive organization.

A process is underway to select an interim president during the initial period when we will stabilize, focus and grow as an independent institution. This will be a short term appointment with the recruitment of a full-term president to take place sometime over the next two years.

This fall saw the college reach its highest enrollment in its 105 year history with 961 students, surpassing an all-time high of 950 students in 1996. Of these students, 85 were new international students from nearly 20 countries bringing international student enrollment to 19 per cent of the student body another all-time high!

For the fourth consecutive year in a row, Nova Scotia Agricultural College was ranked number one in research intensity among Atlantic Canada's 17 universities, according to Research Infosource Inc. and its Canada's Top 50 Research Universities List.

Macleans magazine's 2010 guide to Canadian universities wrote that of the 57 universities in Canada, Nova Scotia Agricultural College

ranked third in student-faculty interaction, eighth in supportive campus environment, eighth in active and collaborative learning and 14th in level of academic challenge.

An official sod turning was held in early November for the Atlantic Centre for Agricultural Innovation (ACAI) which is set to open its doors this summer. The centre will be the first building on our campus to be built to silver LEED standards, following the Green Building Rating System. ACAI will be a one-stop-shop for new agri-business development and will pursue incubation of new products, attraction of new agri-business and acceleration of new technologies.

The Nova Scotia Agricultural College continues to be a leader in alternative energies and environmental sustainability issues with the completion of the first phase of TREEhouse - an on-campus project to convert an older style split-level dwelling into an energy efficient and eco-friendly office space. It will serve as both a teaching tool and a research resource for innovative building concepts.

Last spring, the college launched a new, single ring tradition to provide students and alumni with a true symbol of the university. Custom designed by a local artisan, each ring is handmade and features a textured pattern of barley. Rings can be seen by visiting <http://nsac.ca/alumni/gradring.asp>

His legacy lives on through a fund that provides a significant endowment to the Nova Scotia 4-H Foundation to assist with rural youth development. Scholarships Available For 4-H Members

Young people can gain more than confidence, technical skills and friendship from the 4-H program. 4-H members who are 16 years of age and have been a member for at least two years can apply to win university entrance scholarships.

Presently 4-H members can apply for scholarships from the Department of Agriculture, the Nova Scotia 4-H Council and TD Canada Trust. Each scholarship has specific requirements. The two Nova Scotia scholarships require an essay to be submitted with their completed application form. The essays are judged for style, subject knowledge, originality, quality, interpretation of research as well as spelling and grammar. Scholarships range from \$1,000 to \$2,000.

Under the supervision of the camp's director, each counselor will follow camp rules and set a

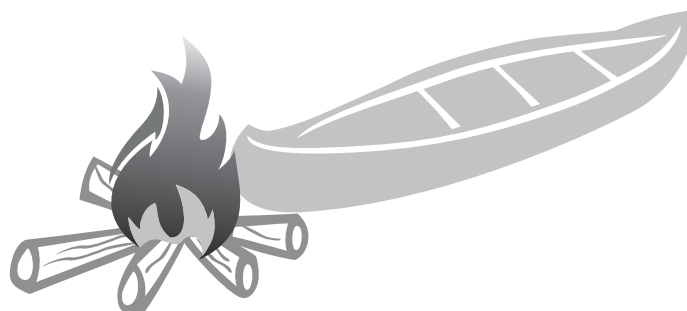

Do You Have the Proper Drivers License?

If you are hauling any trailer (with a truck or tractor) with a combination over 14,000 kg you need a Condition 23 endorsement. For example, your tractor and liquid manure tanker may fit in this category.

If you are hauling any trailer (with a truck or tractor) that has a weight over 4,500 kg you need a Condition 15 Endorsement on your license to legally drive on Nova Scotia roads. These regulations do apply to Class 5 license. If you are interested in obtaining these endorsements please contact your local Department of Agriculture office at 863-4705 or e-mail boydll@gov.ns.ca. We will arrange a date and place for the testing to

take place. Once a testing date is set the following process must take place for each condition.

Process For Condition 15:

Purchase a road test receipt which costs \$47.68 (HST incl.) This can be purchased at an Access Nova Scotia Center or online at <http://gov.ns.ca/snsmr/rmv/licence>

Process For Condition 23:

Complete a Condition 23 application prior to testing.

Have a driver's medical exam completed by your doctor

Purchase a road test receipt which costs \$46.85 (HST incl.). This can be purchased at an Access Nova Scotia Center or online at <http://gov.ns.ca/snsmr/rmv/licence>.

You must register with the Department of Agriculture office in Antigonish first and have a valid drivers license ("N" removed) to be eligible for testing. The Condition 23 application form, the form for the medical exam and more information is available by calling Lauren Boyd at 863-4705.
