

# NOTICE OF PURCHASE

**THIS CERTIFIES** that on the 24th day of July, A.D., 2007, the following property, being all that certain piece, parcel or lot of land situate, lying and being at Lake John Road, in the County of Shelburne, Province of Nova Scotia, assessed as "Owner Unknown" on the assessment rolls of the Municipality of the County of Shelburne vested absolutely in Her Majesty the Queen in right of the Province of Nova Scotia, pursuant to Section 135 of Chapter 18 of the Statutes of Nova Scotia 1998, the Municipal Government Act, which property is more particularly bounded and described as follows:

**ALL** that certain piece, parcel of lot of land situate lying and being at Lake John Road, County of Shelburne, Province of Nova Scotia and more particularly described as follows:

**BEGINNING** at the intersection of the eastern boundary of the Ordinary High Water Mark of the Jordan River and the southern boundary of Lot 46 in Grant Book 17, Page 59;

**THENCE** easterly along the southern boundary of Lot 46 in Grant Book 17, Page 59 to the western boundary of Crown Land with the Provincial Government Parcel Identifier of 16-25-50202 ;

**THENCE** southerly along the western boundary of Crown Land with the Provincial Government Parcel Identifier of 16-25-50202 to the northern boundary of Lot 44 in Grant Book 17, Page 59 Crown Lands with the Provincial Government Parcel Identifier of 16-25-00209;

**THENCE** westerly along the northern boundary of Lot 44 in Grant Book 17, Page 59 Crown Lands with the Provincial Government Parcel Identifier of 16-25-00209 to the Ordinary High Water Mark of the Jordan River;

**THENCE** northwesterly along the varying ways and courses of the Ordinary High Water Mark of the Jordan River to the **PLACE OF BEGINNING**.

**CONTAINING** an area of 55.2 hectares (136.4 acres), more or less.

**SAVING AND EXCEPTING** the public highway Lake John Road.

**BEING AND INTENDED TO BE** a lot of land having Property Identification Number 80116775, Assessment Account No. 09723471 and Municipal Tax Account Number (Roll Number) 09723471, containing 55.2 hectares (136.4 acres).

**TAKE NOTE THAT** the said parcel of land will cease to vest if any person upon application within eighteen months of the property so vesting proves to the satisfaction of the Minister of Natural Resources, (P. O. Box 698, Halifax, Nova Scotia, B3J 2T9) or failing him, a judge of the Supreme Court, that he owns the land and upon payment of the rates, taxes, interest and allowance for expenses paid by the Minister of Natural Resources.
