

# NOTICE OF PURCHASE

**THIS CERTIFIES** that on the 10<sup>th</sup> day of July, 2008, the following property, being all that certain piece, parcel or lot of land situate, lying and being at Moose River Gold Mines, in the County of Halifax, Province of Nova Scotia, assessed as "Owner Unknown" on the assessment rolls of the Municipality of the County of Halifax vested absolutely in Her Majesty the Queen in right of the Province of Nova Scotia, pursuant to Section 135 of Chapter 18 of the Statutes of Nova Scotia 1998, the *Municipal Government Act*, by Certificate of Purchase document 92644013, recorded in the Halifax County Land Registration Office, which property is more particularly bounded and described as follows:

**BEGINNING** at the point of intersection of the southern boundary of the Mooseland Road and the western boundary of lands of Neenah Paper Company of Canada (PID 00642819);

**THENCE** southeasterly along the western boundary of lands of Neenah Paper Company of Canada to a point on a northern boundary of lands of Neenah Paper Company of Canada;

**THENCE** southwesterly along a portion of a northern boundary of lands of Neenah Paper Company of Canada and along the northern boundary of a portion of Ungranted Crown Land (PID 00643254) to the eastern boundary of lands of Darrell Hilchey (PID 41274606);

**THENCE** northwesterly along the eastern boundary of lands of Darrell Hilchey to a point, said point being the northeastern corner of lands of Darrell Hilchey;

**THENCE** southwesterly along the northwestern boundary of lands of Darrell Hilchey to a point, said point being the northwestern corner of lands of Darrell Hilchey;

**THENCE** southeasterly along the western boundary of lands of Darrell Hilchey to a point, said point being on the northern boundary of the lands of David Wayne Bernard and Helen M. Bernard (PID 00643247);

**THENCE** westerly along the northern boundary of the lands of David Wayne Bernard and Helen M. Bernard to the eastern boundary of Moose River Gold Mines Road;
