In an effort to reduce administrative burden for businesses, The NS Licensing of Insurers Regulations has been amended to allow insurance companies to obtain or renew their license for a three year term instead of annually.

A three year fee will now be paid upon renewal, however, the annual license rate will remain unchanged.
