The term “SEA Participating” indicates that admission to the Nursing Home is exclusively through the Department of Health’s **Single Entry Access (SEA)** system. Eligible residents of SEA Participating Nursing Homes pay an authorized accommodation charge and have the health care portion of the long term care facility costs covered by the Department of Health.

If a Nursing Home is “Not SEA Participating”, it means that applicants must apply directly to the facility and that government subsidy is not available to new residents. There is only one such facility and it is located in Guysborough Antigonish Strait (District 7).
