
YOUTH WORKING IN RESTAURANTS

Amendments to Section 68(2) of the *Labour Standards Code* make it possible for young people of 14 and 15 to work in restaurants, providing:

- They are not operating cooking equipment,
- Safety training is provided on all equipment, and
- Adequate supervision is provided.

Q: WHAT IS COOKING EQUIPMENT?

A: [Cooking equipment](#) is equipment used to prepare food by heating: e.g., stoves, deep fryers, grills, ovens, etc.

Q: HOW CAN I FIND OUT MORE ABOUT SAFETY AND SAFETY TRAINING?
