Project: touquoy-gold-project-site-modifications/ Comments: While reading these documents I could not help but wonder if there is a double standard of environmental risk assessment within the province. There is great deal of work, with great expense, required to evaluate the risk of metal contamination and acid rock drainage ARD at mine sites. In contrast, at commercial construction sites within the city of Halifax, underlain by ARD generating rocks, containing the same sulphide minerals present at the mine sites, the developers are only required to dig the rocks out and deposit them at a government approved dumping site. The rocks have been used as harbour infill in Bedford, Kings Wharf, the Fairview Container Terminal Extension, and will soon be used as infill at the South End Container Terminal. The idea is the excavated ARD rocks must be deposited below the harbour low tide water surface so they are not exposed to air that would trigger the ARD reaction. This is the same rationale used when burying the mine tailings in the abandoned open pit while maintaining a water cover over them. So, the interesting part is that the mine must undertake expensive scientific studies to prove the metals in the tailings do not become mobilized over time, but the ARD rock placed in the harbour requires no environmental monitoring or proof that they will not contaminate the marine environment. The groundwater studies conducted at the mine indicate there will be some mobilization of metals out of the tailings. The sulphide concentrations in some of the slate units excavated out of the commercial construction foundations are much higher than the mine rocks. I think it is reasonable to assume there will be metal migration out of the ARD rocks dumped in the harbour. Why is there so much concern about the risk at the mine, but almost no concern expressed about the ARD rocks being dumped in the harbour? Is the harbour environment so contaminated that we no longer care about it? If the metals make their way into the aquatic environment and up the food chain at the mine, won't they do the same in the harbour? I think both sites pose a risk to the environment so why is one considered high risk with lots of permitting scrutiny while the other has no environmental assessment or environmental monitoring requirements? I am not a hydrogeologist or geochemist so I will not make comments on those topics, but as a retired geologist I feel a responsibility to make observations on other aspects of the report. I like other Nova Scotian taxpayers do not want to be on the hook to pay for future reclamation expenses as we are for historic mining operations. The information required to address my observations may already exist in the posted documentation. I will admit that I did not read every appendix or document. There is just too much information provided to review in full, especially when I am spending my own time and my own dime to conduct the review. The hydraulic conductivity of the faults was the focus of the studies in this appended EA. I found the geological information provided on the faults to be very limited. The maps illustrate the strike orientation of the faults, but no dip information was provided. It would have been useful to see the faults projected in the 3-d models. I am assuming they were projected to determine the drillhole depth and orientation required to core the fault structure. A structural geology report that was stated to contain more information on the faults was referenced in the reports as being found in appendix E, but it was not included in the online appendix. It would have also been useful to have the bedding orientations, stratigraphic units, and the anticlinal fold structure projected on the 3-d model showing the

underground workings. I suspect the folding associated with the anticline opens as many fluid pathways as the faults. After all, it provided the pathway for the fluids that carried the gold. Although some of those fluid pathways were subsequently sealed with the deposition of the quartz veins in the voids and along fractures. The drillholes could also have been projected on this 3-d model to visually demonstrate the projected intersection of the drillholes and fault structures. I assume the faults were mapped in the quarry walls and benches. It would have been useful to include some description, possibly accompanied by pictures of the faults as observed in the quarry, along with interpreted degree and extent of displacement on the faults. For example, was there 5 m of displacement or 50 m, and how much brecciation was associated with that movement? Was there 2 cm of clay and breccia on the fault or 2m of brecciation? This provides a much easier method of predicting the fluid flow risk than a simple strike line shown on a quarry map. Given the limited amount of geological data provided, the reader has very limited data to assess the fault fluid flow risk. Due to the orientation of the drillholes, they cross bedding at various angles, some drillholes appear to be almost perpendicular to bedding while others cut bedding at sharp angles. This can impact the visual appearance of the core, with some drillcore being more broken up than others, simply because of the core angle to bedding and the tendency for the core to break along bedding surfaces. The inclusion of the drillhole projected into the 3-d model could have also illustrated the points where the drillholes cut the old workings. I am curious about the orientation of the drillholes. If you want to get a true sense of the width and deformation associated with a fault, it is best to orientate the drillhole so the hole cuts the fault at an angle which is perpendicular to the strike and dip of the fault. Given the mapped dip orientation of the faults is not provided, it is impossible to determine if the holes were drilled to cut them at this angle. In one instance, hole BH-21-10, the drillhole is orientated parallel to the mapped strike direction of the fault it was designed to test. I can only assume the fault dips west or the drillhole would have missed the fault. It is a very odd orientation and makes me wonder if it intersected its proposed target. Two of the drillholes 03 and 09 were moved from their proposed location to reduce the risk to the drilling rig. Mine subsidence was reported in the proposed locations. This raises another issue which I did not see addressed in the report. The mine workings intersect the quarry walls and I assume are exposed there. There is a plan documented in the report to seal the quarry wall around the workings, but there is no plan included on how the workings will be sealed before this liner is installed. What will prevent the clay liner from slumping into the old workings once the load of tailings and water cover are placed on the liner? There appears to be an area of sub vertical mine stope that extends close to surface. They were probably chasing the quartz veins upward from the lower levels of the mine. In other mining districts they stoped very close to surface, to the extent there is often mine subsidence along the remaining roof. This stope extends into the pit. What measures are being taken to prevent the collapse of the old workings, potentially opening a water flow portal towards Moose River. It was recognized by the subsidence observed around drillholes 03 and 09 that there is a risk of further collapse. Although it is not addressed here the proposed plan is to dump the tailings from the three other proposed mines into the pit. Two of the mines will have gravity and flotation plants onsite so only a gold -sulphide concentrate will be shipped to the Toquoy Mine site for final processing. The final tails from these two mines will be sulphide rich. I believe the risk potential for the pit should include these tailings in their calculations because the concentrated sulphides will increase the ARD risk and the risk of metals being released into Moose River. Any prevention measures required to decrease that risk must be taken now while the pit is empty. As noted in the independent third-party risk analyses, the company could opt for long term monitoring and treatment of the pit water. That is a considerable expense, and not one that is addressed with significant documentation in the reclamation plans so I am assuming it is not a serious option being considered. In closing, I

want to state that I hope the mine proceeds because it creates significant good paying jobs.  
However, lets get it right so Nova Scotians will not be on the hook for a major cleanup 20, 50

It's never a question of if a new or expanded gold mine will contaminate the environment, but when, and for how long? Counter to what pro-mining propaganda suggests, gold is not a critical mineral in Canada, and it is not needed for clean energy or other climate solutions. Most of the gold mined today is used for jewelry production 50-60 and for banking and investments 30-40. Since gold can be infinitely recycled, demand going forward can be met by adopting circular economy policies and innovative investment strategies. How could it possibly be reasonable to produce 20 tons of contaminated waste for one new gold ring? For every ounce of gold that Atlantic Gold produces, it extracts 70 tonnes of ore and rock waste. In a single year, that adds up to roughly 8 million tonnes at the Touquoy Mine. Moreover, toxic sodium cyanide is used to extract gold from rock. Gold mining is also energy intensive and results in staggering GHG emissions: Carbon emissions from Atlantic Gold's 2020 gold production at Touquoy would have been the equivalent of taking 106,663 such return flights. <https://www.halifaxexaminer.ca/environment/atlantic-gold-plans-to-mine-paradise/> If you're uncertain as to the environmental harms caused by gold mining today, you are not qualified to make decisions concerning the mining of natural resources. **Re: Comments on the Touquoy Gold Project Site Modifications**

I like to fish trout.

I especially like to fish the rivers and lakes on both sides of Mooseland Road. My family and I take day trips fishing from Oakhill Lake to Diamond Table. On the other side of the road, we like to take quick trips to Sixth Lake. We use my sister's and brother-in-law's cottage on Mooseland Road as our base and a refuge to enjoy the evenings.

A few years ago, we discovered this important place was to be significantly altered by a recently approved project.

Trees were cleared, a deep pit was dug, and when it rained, what a mess.

I suppose the proponent had the required rights to the property. They met the required setbacks and adhered to the conditions of their permits. Still, we had concerns.

Our sense of an expansive space around the cottage had been limited by the construction of a new home too close for our liking.

However, as construction proceeded, the site conditions improved. Today, it is neat and tidy, and remarkably, they turned out to be pretty good neighbors.

Like many property owners with a vacant lot in proximity to their property, if we were consulted, we would have responded that we preferred the lot not be developed. But in a functioning democracy, we don't get to choose when the law is applied.

If a proponent follows the requirements of the law, the law requires approval of the project. Recently, residential construction is a regular occurrence on this road. The area is growing.

Some would argue that residential construction is not a point relevant to an environmental assessment application for a gold mine expansion.

Such a view would be short-sighted.

In 2021, Nova Scotia built 7809 residential dwelling units<sup>1</sup>, with a total value of over \$1.5 billion<sup>2</sup>. Most of those units were built in Halifax, many of which were blasted into, or built above, pyritic slate.

Statistics capturing the footprint size of the 7809 units are not readily available, but I believe it is safe to assume that it is a very large footprint. Likely larger than the footprint of the Expansion Project

application before you. The total value of residential construction activity, defined as the value of time and materials consumed, is certainly much larger than the construction phase of the project under review.

Comparing new residential construction with the expansion of an existing gold mine may on the surface seem silly. But if an impartial “reasonable person” were asked to consider the cumulative environmental impacts of both activities, and consider that the former will likely never be reclaimed while the later will be restored to the state described in the proponents reclamation plan, a reasonable person would find the extreme difference in how we regulate one activity compared with the other as profound.

This letter is not advocating for more environmental regulation on housing activity, nor is it seeking less environmental regulation on the proponent’s project. It is advocating that the Department make its recommendation to the Minister in a manner consistent with the legal concept of the “reasonable person”.

Simply stated, we should apply the same fundamental rule to the Departments recommendation that we do housing activity: if it meets the environmental statutory requirements, it is recommended for approval.

### **Factors that should be included in the recommendation to the Minister**

#### *Environmental Assessment Regulations*

Factors relevant to the Ministers decision on Environmental Assessments, including the Touquoy Expansion application, are found in section 12 of the *Environmental Assessment Regulations made under Section 49 of the Environment Act*. Section 12 contains 11 subsections which describe the factors.

None of these subsections have anything to do with “sustainable development”. Arguably, the last subsection, subsection (i) which states “such other information as the Minister may require.”, could and most definitely should consider economic impacts.

However, that is the central problem. *Economic* impacts.

The Department of Environment is a regulating agency and not a promoting agency.

Since the Westray Report, the Province has worked hard to separate the functions of the regulator from the functions of the agencies tasked with economic development or line departments tasked with assisting specific industries. This approach is generally sound and in the public interest.

However, many years of this policy practice has resulted in an unintended consequence. Some regulators believe that their job requires them to shroud themselves with silos, in which they are protected from the influence of advice and experience of other departments, industry best practices of the private sector, and the public mandates of the elected government of the day. This approach is not sound and not in the public interest.

Factors relevant to the Ministers decision on the Touquoy Expansion application should include economic factors, not just because in the long run it strengthens environmental protection, but because the Environment Act so states.

## *The Environment Act*

Section 2 (b) of the Act states:

*“maintaining the principles of sustainable development including”*

...

*(vi) the linkage between economic and environmental issues, recognizing that long-term economic prosperity depends upon sound environmental management and that effective environmental protection depends on a strong economy, and*

*(vii) the comprehensive integration of sustainable development principles in public policy making in the Province;*

...

Most Supreme Court decisions, federal and provincial, on matters pertaining to the interpretation of legislation and their underlying regulations, cite Elmer Driedger, *Construction of Statutes*. The frequent citation is “...the words of an Act are to be read in their entire context and in their grammatical and ordinary sense harmoniously with the scheme of the Act, the object of the Act, and the intention of Parliament.”<sup>3</sup>

Supreme Court decisions often also dictate that regulations must be read in the context of their enabling Act, having regard to the language and purpose of the Act in general and more particularly the language and purpose of the relevant enabling provisions.<sup>4</sup>

The Minister has inherited a serious problem. The regulations he must follow in rendering his decision on the Touquoy Mine expansion project are not harmonious with the scheme of the Environment Act, the object of the Environment Act, and the intention of [the Legislature].

The regulations do not reflect the language and purpose of the relevant enabling provisions, specifically, divisions (vi) and (vii) above. These divisions are difficult to miss, they are found in the very Purpose of the Act.

### *Population Growth in Rural Nova Scotia*

As stated in the Act, effective environmental protection depends on a strong economy. Evidence of the lack of “the comprehensive integration of sustainable development principles in public policy making in the Province”, can be found in the difference between the population growth of Metropolitan Halifax vs Rural Nova Scotia.

Obviously, it is not the only factor, but the importance of sustainable development projects to the economic well being of rural Nova Scotia must not be discounted. We must do a better job of administering the Act.

Every senior policy maker in the province should be aware of these statistics, particularly those with regulatory responsibility for approving or rejecting significant projects.

A widely reported Statistics Canada release indicated the urban population of Nova Scotia had grown by 7.7% from 2016 to 2021, and in the same timeframe, the rural population had grown by 1.3%.<sup>5</sup>

This was welcome news, but policy makers would be well advised to note that Statistics Canada’s definition of rural nova scotia is very different from what many Nova Scotian’s commonly refer to as “rural”.

Given the dramatic growth of Metropolitan Halifax, lets simplify the statistics and evaluate the evolving reality of Nova Scotia: there is Metro Halifax and there is everywhere else. The tables below illustrate the population growth of Metro Halifax vs Non-Metro Nova Scotia.<sup>6</sup>

The population decline of non-Metro Nova Scotia is alarming and accelerating. If the current trend continues, a critical tipping point will be reached before the end of the next census cycle. The population of Metro Halifax will exceed the population of everywhere else in the province.

Tinkering with economic development policy will not correct the impending statistical tsunami.

It is why section 2(b)(vii) of the Environment Act is so important to Non-Metro Nova Scotia. We need a comprehensive integration of sustainable development principles in public policy making for the entire Province.

It is also one of the reasons we need to approve the Touquoy Mine Expansion Project.

I am not asking the Department to do less. I am asking it to do more. I am asking it to stop choosing which sections of the Act it will follow. I am asking it to fulfill its fiduciary obligation and follow all sections of the Act.



We all need to do a better job of protecting the environment. A good place to start is how we allow the Environment Act to be administered.

## **Conclusion**

As noted in the beginning of the comments, I frequent this area and very much enjoy this important part of the province. I also believe that we can protect the environment and grow the economy. Like anything worthwhile, it takes a lot of work.

I have reviewed the applicant's documentation and I am confident that the team responsible for this project, including third-party technical specialists, have completed thorough investigations, analysis, and design to provide fulsome responses to the information requests, and I am confident in the conclusions presented. The work carried out and presented in St Barbara's most recent submission confirms the earlier conclusions: in consideration of the assessment, mitigation, and planned follow up and monitoring, the planned modifications to the Touquoy site are not likely to result in significant environmental effects.

To Whom It May Concern:

I do not support the proposed modifications to the Touquoy open-pit gold mine, nor can I support any such project that would compound the toxic legacy of open-pit gold mining in Nova Scotia.

A comprehensive and holistic view of land-use planning is necessary to predict (and prevent) adverse impacts to both wildlife and people. Therefore, we must seriously consider the cumulative impacts of these projects on ecosystems and communities, rather than viewing them solely as independent sites, components, or modifications.

**I use the word “modifications”** with great reluctance in this instance. As Eastern Shore Forest Watch Association clearly stated, “The changes in use of the mine site and the considerably lengthened timeline are so drastic that they hardly can be called mere modifications.”

**In spite of how Atlantic Gold’s documents are written, the environmental harms will** not be restricted to a tidy little block (aka, **the “mine footprint”**). **As a result**—or by design—the company has repeatedly underestimated the cumulative effects on nearby watersheds, wetlands, and wildlife. Given that Atlantic Gold has distorted the irrefutable evidence to suit **the company’s narrative, how can we have any confidence in the information they’ve** presented?

How can we have any confidence in Atlantic Gold or the Touquoy mine when the company failed to meet the terms and conditions that were issued back in 2008?

How can we trust a company that has faced federal (3) and provincial (32) charges for violating environmental legislation at this very mine?

And perhaps the better question: why should we?

Why should we entrust Atlantic Gold with the well-being of this and future generations?

The sixth mass extinction is an ongoing extinction event, the likes of which has never before been seen in human history.
