Dear Sirs,

I wish to advise you that the Shelburne Port Authority has just taken over control and ownership of the former Government Wharf as of the 4th. of June 2002.

I am very pleased to inform you that the Shelburne Port Authority and the Town of Shelburne would like to encourage you to use our site as a holding area for the storage of washed quartz on a site that we own. This would be in very close proximity to the wharf for shipping. The area is zoned Industrial and Commercial.

Shelburne boast the third best natural harbour in the world. We have twenty-seven feet of water at low tide at the wharf and the approaches can offer up to forty-two feet of water. The port is ice free, a pilot is not required, nor is dredging, and there are no unions.

Our plans are to develop the wharf and site to include additional holding areas and more berthing. The Authority owns a water lot that is approximately one thousand feet around the perimeter of the wharf. This will permit rapid expansion of our facility.

Re: Port of Yarmouth Facilities


The Port of Yarmouth welcomes the opportunity for new economic activity in Yarmouth County, such as Black Bull Resources' quartz mining operation. We would like to enter into negotiations with Black Bull to move quartz product through our port facilities once all environmental and other approvals are received.

The Lobster Rock Wharf facility, as shown on the attached sketch, is owned by the Yarmouth Area Industrial Commission and this facility will be the one used when the quarried product is to be shipped from Yarmouth. This area is presently Zoned M-2 Waterfront Industrial, as defined by the Town of Yarmouth By-laws.

The closest residential dwelling to the storage area is over 60 meters away. Between this residence and the lay down area, are Water Street, the primary transportation route on the waterfront and an operating machine shop and the associated storage yard for their steel products.
