Shear Wind Inc. (SWI) is pleased to present thirty-nine (39) copies of the Addendum to the Glen Dhu Power - Wind Project Environmental Assessment and Registration Document. This Document has been prepared in response to the Minister's Request for Additional information of October 8, 2008 with regard to the Environmental Assessment and Registration Document.

SWI has addressed each of the requirements for additional information identified by the Minister. In response to issues raised during the EA review, SWI has conducted extensive investigations and addressed the environmental and human health issues.
