# Winds bring opportunity

No one has to tell the people who live here about the strong winds that blow off the ocean. There is another strong wind blowing across the District of Guysborough and that's the wind of progress and opportunity for a stronger future. When the onshore terminal for Sable gas came here, the benefits began to flow. That offshore project may be past its peak, but we can turn those benefits to our advantage for years to come.

The Municipality of the District of Guysborough is partnering with Nova Scotia Power to submit a proposal to develop Sable Wind, a project that will create jobs and other economic opportunity and activity in our district. The proposed site is at the east end of the Municipality near Canso/Hazel Hill.

This proposal is about the municipality and the people of the district taking hold of our future and becoming a player in the development of long-term, environmentally responsible renewable energy. We will use that energy here and to contribute to the province's renewable energy goals.

The residents of the District of Guysborough have spoken loud and clear of their determination; their vision to build a future for and in this district. Sable Wind is a progressive step into the energy future and an exciting opportunity to breathe life into that vision.

Today this is still a proposal. Further steps are outlined on the next few pages. The first hurdle of course is the Municipality winning the bid for the project. Our proposal will be submitted on June 27, 2012. On Sunday, June 17 we'll have an open house at the Fanning Education Centre where you can ask questions, and more importantly, we can hear your opinions.

# Natural advantages will bring real benefits

Let's think about what this means for us, in both practical and intangible terms.

For the past year or so, we've been telling everyone who would listen about the District of Guysborough's Natural Advantages. Harnessing the power of the strongest winds in the province is one of those natural advantages.

The Sable Offshore Energy project provided various benefits to the district. The Deep Panuke offshore gas project will add to those. But one thing is certain about oil and gas, no matter where it is. It is a finite, non-renewable resource. It will run out and the benefits—the power it generates, the revenue it brings in, and the jobs it creates—will run out right along with it.

We can take the benefits that come from offshore gas, in revenue to the district, and continue to pay for services and hold down taxes until the money runs out. Or we can invest the revenue wisely, create a lasting legacy for the district and join the future as a major source of renewable power. The second choice keeps benefits flowing to the people of the District today, and guarantees more

benefits keep on flowing for years, indeed for generations to come.

There will be jobs in construction and in ongoing operations. Economic spin-offs and economic opportunities. Those are practical benefits.

Think too about the intangible—what this says about our district. We will be the first municipality in the province to invest in, build and own a major wind power project. It says we aren't just making noise when we talk about our Natural Advantages—we know how to use them responsibly to create prosperity. It says we are part of the global energy solution and are moving confidently into that future. It says we are here to stay and willing to do what it takes to build a future here, in the District of Guysborough.

It says to people everywhere, that in the north east corner of Nova Scotia there is a community, large in geography and in natural advantages. Not too many folks live here, but those that do have pride in their present and confidence in their future. It says the District of Guysborough is not just a place to watch, it may well be the place to be—or the next big place.





# What is the Sable Wind project?

The Municipality of the District of Guysborough is proposing a wind energy project near Canso/ Hazel Hill, with the support of Nova Scotia Power. If approved, this 13.8 megawatt wind energy project would be located primarily on municipally owned lands. Named the Sable Wind Project, it is expected to produce enough energy to serve approximately 4,600 homes. Subject to winning a competitive bid process, road construction would begin in 2013 and conclude with six (6) wind turbine generators being operational before the end of 2014.



Sable Wind Project Layout

This project is subject to the provincial Environmental Assessment (EA) process. Studies completed as a part of this process include those related to birds, bats, wildlife, plants, wetlands, watercourses, groundwater, and noise.

Community engagement activities and consultation opportunities are underway and will continue throughout the project planning and EA process.

# What will this project mean for the community?

If approved, the Sable Wind project will generate long term economic benefits for the Municipality of the District of Guysborough. The Municipality would benefit from increased tax revenue, rent from the wind turbines, and turbine revenues over a period of 20 years. Jobs will be created during the project's construction phase and ongoing operations. Local businesses will directly benefit from this increased economic activity in the region.

### What is a wind turbine?

Wind turbines are used to transform the kinetic energy from the wind into mechanical energy to make electricity. The towers are made of steel while the blades are typically made from fiberglass-reinforced polymers.







# Where exactly will the wind farm be located?

The area for the proposed project is located on lands near Canso/Hazel Hill, with turbines sited over 1 km from the closest resident. The project area is approximately 137 hectares with none of the lands currently being used as an economic resource.

# Why is another wind energy project needed?

Nova Scotia's Department of Energy has set a renewable energy target that 25% of Nova Scotia Power's generation must come from renewable energy sources by 2015. A successful Sable Wind project could play a role in this future achievement.

# Who is the project team?

The Municipality of the District of Guysborough is the majority project partner; Nova Scotia Power is the minority partner.

# When would it be known that the project is being constructed?

This project will only go ahead if the Municipality is successful in winning the bid which will be submitted by June 27, 2012. The Renewable Energy Administrator (REA) is expected to make its decision within 30 days of that date. # When will the Environmental Assessment be available for public review?

The Project Team is planning to submit the Environmental Assessment before the end of June 2012. There is a 30 day comment period for the public to submit their comments to Nova Scotia Environment (NSE). NSE takes an additional 20 days to evaluate the submission and the public comments prior to the Minister providing his decision.








