

Are you eligible to apply?

Is your suspension for accumulation of demerit points under section 282(6) or 283(6) of the Motor Vehicle Act?

Yes > You may be eligible.

No If you have any other suspension, you are not eligible.

Have you had a suspension for demerit points in the last 5 years?

Yes > You are not eligible.

No > You may be eligible.

A conditional licence is only for work or school

Work: You need your employer to sign the application form. If you are self-employed, attach a copy of your Joint Stocks certificate.

School: You need a signature on the application form from a school administrator or teacher who can verify your schedule. You also need to attach your school schedule on school letterhead.

Things to consider before you apply

A conditional licence is approved only if the Registrar determines there is sufficient cause to grant your request. It is not automatic.

You will not qualify if you have access to other modes of travel.

Example: public transportation, family, friend, coworker, or employer.

You must pay applicable fees/fines to apply. The application fee is **NOT** refundable if your request is denied.

What the Registrar considers when reviewing your application

- Hours requested: Explain your needs clearly. Applications for excessive hours will be denied (i.e. 12 hours/day, 7 days/week).
- **Driving record:** Your full driving history is reviewed, including collisions, convictions, complaints and pending motor vehicle related charges.
- Completeness: Incomplete applications will delay the review of your file.
- Accuracy: The information will be verified. Inaccurate applications will be denied.
- Surrendered driver's licence: If you are unable to do this, explain why on the form.

Important information if you are approved for a conditional licence

- Your conditional licence will be cancelled immediately if you get a new suspension, conviction or you violate the conditions. Police can lay charges if you drive outside the conditions.
- A conditional licence is not valid for any suspension type other than your current point suspension.
- You can apply to have your conditional licence amended if there are any changes to your work or school schedule.
- Other jurisdictions may not recognize the validity of your conditional driver's licence which could result in police laying charges.

Submitting your application in person or by mail

Apply in person at any Access Nova Scotia or Registry of Motor Vehicles office or mail your application with fees and driver's licence to:
