

## **FUR BUYER LICENCE: APPLICATION/RENEWAL FORM**

A Fur Buyer Licence is valid for one year (April 1 – March 31 of following year).

Persons applying for a Fur Buyer Licence must possess a valid Nova Scotia Wildlife Resources Card (WRC). Information on how to obtain a WRC is available online at: <a href="http://novascotia.ca/natr/hunt/">http://novascotia.ca/natr/hunt/</a> or by contacting your local Department of Natural Resources & Renewables office.

The fee for a Fur Buyer Licence (until March 31, 2020) is \$35.85 (includes HST) which may be paid by credit card, cheque or money order made payable to the **Minister of Finance**. The licence fee is subject to change, without notice, after March 31 each year.
