



## **TAXIDERMIST LICENCE: APPLICATION/RENEWAL FORM**

A Taxidermist Licence is valid for one year (April 1 – March 31 of following year).

Persons applying for a Taxidermist Licence must possess a valid Nova Scotia Wildlife Resources Card (WRC). Information on how to obtain a WRC is available online at: <http://novascotia.ca/natr/hunt/> or by contacting your local Department of Natural Resources & Renewables office.

The fee for a Taxidermist licence is \$14.35 (includes HST) which may be paid by credit card, cheque or money order made payable to the **Minister of Finance**. The licence fee is subject to change, without notice, after March 31 each year.
