Minister's Message

Bright summer weather is a sure sign that things are blooming in Nova Scotia's agriculture industry. The hard work of farmers, producers and the agrifood and beverage sectors is leading to success and as Minister of Agriculture I am very excited to work with our stakeholders to help the industry continue to grow.

Our wine industry is putting Nova Scotia on the map with a global food culture that is hungry for new tastes and experiences. The industry's success was celebrated in July with the Lieutenant Governor's Awards for Excellence in Nova Scotia Wines. Congatulations to Avondale Sky, Gaspereau Vineyards and Lightfoot and Wolfville Winery who were recognized at this year's awards for their world-class wines.

As this year's award recipients highlight, Innovation and a focus on quality are hallmarks of Nova Scotia's wine industry. In our recent budget, we invested \$3.5 million in a Wine Development Program to support product research and development, planting more grapes to meet the growing demand for our wine and export market development. The ONE Nova Scotia report made the link between a strong agriculture sector and our ability to compete successfully internationally. Wild blueberries, new varieties of apples and haskap berries are just a few Nova Scotia products that are finding new markets and helping to grow the importance of our agriculture industry. Blueberries were our number one agrifood export in 2015 at \$123 million. That helped to feed a 21 percent increase in those exports to \$385 million and highlights the growth that agriculture makes possible .

A healthy agriculture industry secures jobs for Nova Scotians and it helps to ensure the sustainability of our food supply. Select Nova Scotia is busy sharing the good news story about buying locally grown and produced products through its website, social media and with partners in communities throughout Nova Scotia. Winter Grain Deadline

The application deadline is fast approaching for Winter Grain – August 31, 2016

The deadline for planting is:

- October 7 for Annapolis, Kings and Hants West counties (Zone 1)
- September 27 for Colchester, Hants East, and Halifax (Zone 2)
- September 20 for the rest of the province (Zone 3)

Forage Establishment Deadline

The deadline to apply for Forage Establishment is October 15.

Fields of legumes and legume-grass mixes seeded by July 1 as well as grass seeded by September 1 are eligible for coverage.

Fall Application Deadlines 2016

- Winter Grain August 31
- Forage Establishment October 15
- Raspberry October 31
- Strawberries November 14
- Grape Insurance November 15
- Blueberries November 30
- Tree Fruit November 30
- Tree Insurance December 1

Cancelling Crop Insurance

Most Crop Insurance contracts are continuous. This means they do not terminate at the end of the cropping season (unless a producer requests cancellation in writing by the deadline date).

The benefit of this approach is that you, as a client, do not risk being unable to insure your crop for the entire cropping season if for some reason you do not make an application by the required date. At the same time, if you do not cancel by the cancellation deadline, you will be expected to insure your crop during the current crop year.

Dairy Insurance Coverage for Heifer Calves

The Nova Scotia Crop and Livestock Insurance Commission now accepts Dairy heifers (prior to their first calf) and calves for insurance by both licensed and unlicensed producers under the Dairy Livestock Insurance Plan.

If you are raising dairy replacements or dairy calves and are interested in coverage for disease, etc., you no longer have to be a licensed dairy producer under the Dairy Industry Act.

Problems with Harvest?

AgriInsurance clients who experience problems or delays at harvest are reminded of their obligation to advise the Commission promptly (within five days) with a Notice of Damage. You must provide the Commission with a Notice of Damage when:

- At any time you believe your crop may be reduced as a result of an insurable peril.
- You think your crop will be reduced due to harvesting delays as a result of an insurable peril.
- You note a reduction in yield due to an insurable peril once you complete harvest. (Must be reported within five days of harvest) or
- Your harvest could or does extend past the end of the crop insurance crop year end date (see dates below).

Failure to provide this reporting could result in the denial of any claim for losses to your crop. When in doubt report your concerns to the Commission office.

- Potato December 20

Programs and Business Risk Management

Growing Forward 2 Programs

The Nova Scotia Department of Agriculture, Programs and Business Risk Management (PBRM) Division has intake periods for a variety of application and proposal-based programs for the agricultural industry. Program staff welcome your inquiries regarding any projects you are pursuing or wish to pursue for your farm operation or agri-business.

Important Changes for 2016-17

<u>NEW</u> for the 2016-17 program year, clients must sign and return their Letter of Agreement within <u>60 days</u> of the date on the Letter of Agreement. This applies to <u>all</u> programs. It is extremely important to complete this activity in the 60 day timeframe. Failing to return the signed Letter of Agreement within 60 days could result in the loss of funding for your project.

How can we send and receive information during a postal strike?

Programs will continue to do business by email or fax. If we do not have your email, please contact our office. You may also bring items that you need scanned or faxed to your regional office and they will be pleased to assist you.

Early claiming

You may submit a claim as soon as you sign your Letter of Agreement and complete one of your projects. To claim, please submit a signed claim form, along with your invoices and proof of payment to the programs office. The turnaround time on claims at this time of year is very prompt.

AgriRecovery Program

Programs and Business Risk Management (PBRM) would like to remind maple producers of the AgriRecovery Initiative that was launched in January of this year and is still currently accepting applications.

The **Canada-Nova Scotia Maple Sector Initiative** offers maple producers assistance in recovering from the costs to re-establish sap collection systems damaged by the unusually heavy and repeated snowfalls in the winter of 2015. Up to \$850,000 will be invested together by the federal and provincial governments to support affected maple producers.

Depending on eligibility, assistance includes 90% reimbursement for eligible components of the sap collection system up to \$5.50 per affected tap. Eligible components include food grade mainlines/lateral lines, fittings, connectors, manifolds, spiles, t's, support posts and wire for mainlines.

Invoices and proof of payment of eligible collection system components must be provided and components must have been purchased between February 1, 2015 and September 30, 2016 and installed by December 31, 2016. Multiple claim forms may be submitted up until the deadline of September 30, 2016.

Proper Preserving and Traceability Session

Perennia is planning a short session aimed at small food processors selling at farmers markets or to independent retailers to give practical information on vital practices to ensure your food is safe and avoid recalls. This session will provide an overview of some of the risk factors for food borne illness and introduce some simple tools for ensuring production of a safe product such as temperature monitoring, pH measurement, moisture control, and record keeping. It will also cover what to do in the event of a recall, the importance of testing your recall program, picking a recall team and traceability best practices including correct labeling.

Prerequisite programs are written to control operational and environmental conditions within the facility to ensure the production of safe food. At the end of the program, you will be able to:

- Describe the components of a HACCP prerequisite program
- Begin the process of implementing a prerequisite program
- Identify good manufacturing practices
- Document your prerequisite program

The HACCP system, comprised of the HACCP Prerequisite programs, the HACCP plan and reassessment, is a preventative approach to food safety.

Establishing control of identified hazards at critical control points during manufacture ensures safe production of food.

The development of a HACCP plan requires a comprehensive review of the product line in order to complete a hazard analysis, determine critical control points, set critical and operating limits, and establish procedures for monitoring and deviation with accurate validation and verification processes and record keeping.

At the end of the program, you will be able to:

- Discuss food safety, food quality, global food safety standards and prerequisite programs as building blocks for HACCP
- Differentiate between physical, chemical and biological hazards
- Apply the Codex 12 steps to HACCP to develop and maintain your own HACCP plans
- Conduct a hazard analysis and utilize the HACCP decision tree to identify critical control points

Blueberry Maple Scones

Prep Time: 10 Minutes
Cook Time: 12 Minutes
Total Time: 22 Minutes
Yield: 10 to 12 small biscuits
Chef. Repéc Levellée

Chef: Renée Lavallée Source: The Canteen

Ingredients:

1/4 cup sugar
3 cups all purpose flour
1 tsp baking powder
1/2 cup butter
1 egg
1/4 cup Nova Scotia maple syrup
3/4 cup buttermilk
1 Lemon, zest
1 orange, zest
1 cup Nova Scotia wild blueberries, fresh or frozen
1/4 cup dried blueberries

Method:

In a bowl, combine sugar, flour and baking powder. Grate in the frozen butter and mix until it resembles coarse meal. In separate bowl, mix the egg, maple syrup, lemon zest, orange zest and buttermilk. Add the blueberries to the dry ingredients. Pour the wet ingredients into the dry and mix gently. Pour onto a floured surface and gently bring dough together. Pat down with your hands until ½ inch (1cm) thick.

Cut into squares or circles (your choice). Place on parchment sheet lined baking tray. Bake for 10-12 minutes in a pre-heated 400°F (200°C) oven.

Community Meetings to be Held

Extended Learning Dalhousie University Faculty of Agriculture

Online - University Credit Courses

Transition to Organic Agriculture

This course is recommended for students looking for a general introduction to organic agriculture. It consists of five stand-alone modules: Why organic? Organic Certification, Planning the Farm System, Transition to Organic Crop Production, and Transition to Organic Livestock Production. Throughout the course students will be encouraged to participate in discussion groups and use the organic information resources currently available over the Internet.

Fall Semester: September- December

Composting and Compost Use

Composting and the utilization of organic matter produced on the farm provide the basis for soil fertility in organic systems; however, potential benefits derived from compost use are often limited by the supply and quality of composts produced on-farm. The objective of this web-based course is to teach composting primarily by providing students with the opportunity to make their own compost over a period of 13 to 15 weeks.

Fall semester: September- December

Principles of Organic Horticulture

Study of the principles that form the basis for organic production of horticultural crops. Special attention is given to regulations, soil fertility, organic soil amendments, compost and mulches, crop rotation, plant health, management of diseases and pests, and companion planting. Students will apply their knowledge through an instructor-approved project that will be presented on-line using an appropriate multi-media venue.

Fall Semester: September- December

Issues in Agricultural Health and Safety

Gain a better understanding of the health and safety issues present on Canadian farms with this series of online modules. You will learn about the health and safety situation in the agriculture industry, the major health and safety risks and explore some strategies for improving the current situation.

Winter Semester: January-April

Organic Field Crop Management

This course will introduce students to organic principles and practices applied to the production and management of field crops. The criteria for optimum yield and quality of field crops are presented within the context of organic farming principles, sustainable soil and nutrient management, and the requirements for organic certification.

Winter Semester: January-April

Organic Livestock Production

This course provides information on organic livestock production in general, as well as more detailed analyses of organic beef and sheep, dairy, and swine and poultry production. An in-depth study of organic approaches to livestock health is included. The course is divided into five stand-alone modules: Introduction to Organic Livestock Production, Organic Beef and Sheep Production, Organic Dairy Production, Organic Swine and Poultry Production, and Health Management in an Organic Livestock System.

Winter Semester: January-April

Agriculture, Food and Well-Being

This case-based course investigates local, regional, and global issues related to agriculture, food, and wellbeing. Learners will work together to develop practical solutions for real life cases thus enhancing their understanding of global economic and politica

This course will help students enhance their critical thinking skills and systems analysis capacity. Students will explore how agriculture and food are related to, interconnected with or impacted by people, the land and environment, and ultimately social/economic wellbeing.

Nutrient Management Planning Certificate (Online)

This online certificate will provide training to nutrient management planners and those implementing nutrient management plans in Atlantic Canada

September-November

Master Gardener Training Program (Online)

Get together with other gardeners who share a passion for horticulture and are dedicated to learning and growing their knowledge to share with their community.

The Master Gardener training program caters to participants who have a passion for gardening, wanting to expand their knowledge in the horticulture field, or wanting to become a Master Gardener! The training program consists of four independent-study classes available online and a one-week, on-site summer school. Participants have the opportunity to take one course or all courses.

October/November/February class intakes

Introductory Welding

As a beginner to the art of welding, you will learn theory, technique and shop practice for arc welding. You'll also get hands on experience as you work on projects from start to finish. You will learn identification of metals, Arc welding, and measuring and cutting using a torch.

November 15 to December 1, 2016- Tuesday and Thursday evenings from 6:00-9:00 p.m.

NEWBeekeeping for Newbees (Classroom and Online)

This three-part course is designed to help people learn the basic requirements of keeping honeybees. Each part includes a half-day classroom session and 30-day access to an online course. Come to the 39th Annual Nova Scotia 4-H Show

4-H members are looking forward to a very special event this fall - the 39th annual Nova Scotia 4-H Show. The largest 4-H Show in Canada takes place September 30 - October 2 and all the exhibitors are 4-H members from 9 - 21 years of age.

Hosted this year at the Nova Scotia Provincial Exhibition Grounds in Bible Hill this annual family event offers something for everyone and is an excellent opportunity for the public to experience the 4-H youth leadership program in an interactive way.

4-H members are eligible to compete at this event after achieving top honours at a local exhibition with their life skills or livestock projects. At this provincial event 40 projects, 90 classes, and 2400 entries are expected to be displayed!

The Nova Scotia 4-H Show began in Windsor and was held there for a few years. It then began to move to other locations around the province so 4-H members could see more of Nova Scotia. Also, by taking the show on the road other communities could benefit from the revenue generated by the influx of people attending. The organizing committee then shifted from having provincial representation to having the county 4-H councils take on more responsibility for the show.

This year the Central Region (Colchester, Halifax East Hants and Cumberland) 4-H Leaders Council have the responsibility of making site arrangements, providing security, fund raising and promotion.

Highlights of the Nova Scotia 4-H Show include livestock auctions, fashion show, dog obedience and handling trials, tug of war, bake-off, grand champion showmanship class, and dairy and beef cattle selections for the Royal Agricultural Winter Fair in Toronto.

The Nova Scotia 4-H Show is open to the public and admission is free. 4-H families and the general public are invited to view the 4-H members' livestock and life skills projects. Competitions begin Friday, September 30 and end on Sunday, October 2 at noon.

4-H Members Win University Entrance Scholarships

Along with gaining confidence, technical skills and friendship from the 4-H program, young people who are 16 years of age and have been a 4-H members for at least two years can apply to win university entrance scholarships.

Presently 4-H members can apply for three provincial scholarships from the Nova Scotia Department of Agriculture, the Nova Scotia 4-H Council, and the George MacNeil Scholarships. National scholarships such as the TD Agriculture Scholarship, L.E.A.D. (Leadership Excellence Awards of Distinction) and the CIBC 4-H Post Secondary Education Scholarship are available through 4-H Canada at http://apply.4-h-canada.ca/.



Each scholarship has specific requirements to be submitted with their completed application form and scholarships range from \$500 to \$20,000.

The year Ella Lentz, Hants County won the Nova Scotia Department of Agriculture Scholarship valued at \$1000. The department scholarship is presented to students enrolling in their first year program in Agriculture, Veterinary Science, or other recognized disciplines. Katelyn Stokes, Kings County was awarded \$1000 from the George MacNeil Scholarship Fund.

The Nova Scotia 4-H Council university entrance scholarship was awarded Katherine Lahey, Lunenburg County; Julia Vosman, Antigonish County and Maria Penman from Halifax East Hants. Julia Vosman was also the 2016 Nova Scotia recipient of the TD 4-H Scholarship and was one of fourteen 4-H members across Canada to receive a \$2500 scholarship for entrance to her first year of university. Madalyn Nielson, Pictou County and Sidney Patton, Colchester County also were TD 4-H scholarship recipients.

A 17 year old member with the St. Andrews 4-H Club, Julia is honored to receive this scholarship. "It will be put to good use as I attend the Dalhousie Faculty of Agriculture to pursue a B.Sc. in agriculture with a major in Animal Science, said Julia. "My ideal career would be anything that is hands on with animals, such as a livestock specialist, animal nutritionist, or even a veterinarian.

Julia added "The opportunities that 4-H offers are endless, but the most significant one for me would be the public speaking skills. This is a skill that will develop confidence and will not only help members while in 4-H but in school and future careers. The motto "Learn To Do By Doing" is very fitting as it gives many members opportunities to learn about and explore 4-H projects and agriculture that they wouldn't have access to otherwise. My experiences with 4-H have been unforgettable and I will carry them with me wherever I go in life. I hope to always be a part of this amazing organization."

All senior 4-H members and 4-H Alumni who are 16 - 24 years of age as of the competition date can enter this competition on Friday, September 30, 2016, 6:30 p.m. It will take place during the Nova Scotia 4-H Show at the Nova Scotia Provincial Exhibition Grounds in Bible Hill.

The contestant that wins the provincial contest will be sponsored by the Nova Scotia 4-H Council to participate in the 32nd annual Canadian Young Speakers of Agriculture National Senior Public Speaking Competition at the Royal Agricultural Winter Fair in Toronto, Ontario on Saturday, November 5.

While the Nova Scotia competition is for past and present 4-H members only, contestants at the national level were also competing against fourth year University of Guelph students or graduates already working in the agricultural industry.

4-H members are encouraged to doing public speaking and demonstrations along with their project work during the 4-H year and each spring 4-H clubs, counties and regions hold communications competitions.

This life skill is invaluable in so many facets of life that 4-H members will often credit 4-H for giving them the opportunity for that specific training. The Nova Scotia competition rules are the same as those for the Royal competition. Each contestant has to give a five to seven minute prepared speech on one of five selected topics and they have to introduce and thank another speaker.

The 2016 competitors have five agriculturally related topics from which they can choose to speak:

• What is the impact of public opinion on Canadian farmers?

How would you explain a GMO to a non-farmer?

- What does the next generation of agriculture bring to the table?
 - How can we improve the media's perception of Canadian agriculture?
- Old MacDonald had a farm ... But what about Mrs. MacDonald?

Contestants may choose to use a flip chart. Or appropriate posters to illustrate their talk. Slides, films, videos or overhead projectors will not be allowed. A complete set of rules, as well as the scoresheet, will be sent to all applicants prior to the Nova Scotia competition.

ATTENTION: RECYCLING USED PESTICIDE CONTAINERS HERE'S WHAT TO DO:

- Allow the formulation to drain from the container for at least 30 seconds.
- Add at least 20% of the contents of water to the container, replace lid, and rotate so that the interior of the container is rinsed.
- Empty the rinse water into the spray tank and drain for 30 seconds.
- Repeat the above procedure twice more.
- Render containers not useable by puncturing.
- Leave label on the container.

Containers that have been handled in this way are technically suitable for disposal.

Livestock Identification Update

The objective of the national Livestock Identification and Traceability Program is to provide accurate and up-to date livestock identity, movement and location information to mitigate the impact of disease outbreaks, food safety issues and natural disasters.

Cattle, bison and sheep need to be identified with an approved tag before leaving their farm of origin. Livestock traceability systems are based upon three basic elements: animal identification; premises identification; and animal movement.

Premises are defined as sites where animals are grown, kept, assembled or disposed of. In Nova Scotia, the Department of Agriculture has developed a system to register sites and assign a unique premises identification number. This premises identification number is necessary to identify unique locations and is required for movement reporting. Agricultural Biodiversity Conservation Plan

Farmers who are interested in and aware of habitat conservation and biodiversity issues have an opportunity to have a Biodiversity Conservation plan completed for their farm.

This plan will help identify possible Beneficial Management Practices (BMP's) that promote the maintenance or enhancement of biodiversity on their farms. The intent of the plan is to provide farmers with a tool that can help them increase the robustness of the ecosystems that surround their farms.

A typical plan would include identification of riparian areas, wetlands, upland areas, woodlands, pastures and hayfields. Each identified item would be assessed and recommendations for enhancing potential biodiversity made.

There is no cost to having one of these plans developed and you are not required to follow the recommendations but it is a great way to help develop an often overlooked part of your farm.

Disposal of Used Farm Sharps

The Agriculture office in Bible Hill has a supply of sharps containers available at no cost for producers. Remember sharps must not be discarded in regular household garbage. Sharps should be collected on farms in rigid, puncture resistant containers with tightly secured lids. You must check with your

municipal waste disposal department for instruction on how to dispose of these sharps once they are in a secured container. Drop in to pick up your containers during our regular office hours. For more information contact 902-893-3645

Do You Have the Proper Driver's License?

If you have a farm tractor trailer combination over 14,000 kg, you need a Condition 23 Endorsement and if you are hauling any trailer (with a truck or tractor) that has a weight over 4500kg, you need a Condition 15 Endorsement on your license to legally drive on Nova Scotia roads. These regulations apply to class 5 license.

Need a Sharps Container?

Livestock producers generate medical waste on a regular basis. These wastes include sharps such as syringes, needles, broken glass tubes, lancets and scalpel blades. If not disposed of properly they can injure livestock and family members; increase risk of spreading infection; pollute the environment; and put waste handlers at risk. Sharps must not be discarded in regular household garbage. Sharps containers have been specifically designed for disposing of sharps. When the container is full, the contents should still be considered potentially infectious to humans and animals, but the risk is low. For disposal in any municipality, you must first check with your local disposal site to see what they have in place to accept sharps.

These containers can be picked up at the Department of Agriculture office in Cornwallis Park. Call 902-638-2395 for hours and information.
