Tractor Safety Courses

If you operate a tractor and farm machinery you know that safety is important. This course is designed to increase awareness and test competency of tractor operators with regards to safe operation and use of farm tractors and implements.

This following people can take this course:

- 14-16 year olds with a valid Nova Scotia Class 8 driver's license who want to be able to haul equipment on Nova Scotia roads and,
- Those with a valid class 5 driver's license who want to increase their tractor safety knowledge and skills.

Participants with a valid Nova Scotia Class 8 driver's license who successfully complete the course will receive a wallet card that enables them to operator a tractor with an attached implement on Nova Scotia Roads. Please note that the wallet card is valid for a farm tractor and trailer, if the combined weight of the vehicle combination weighs 14 000 kg or less.

Nova Scotia Crop and Livestock Insurance Commission

Why should I have AgriInsurance?

As a producer, you are constantly faced with factors that are beyond your control. Things like adverse weather, disease, wildlife, and insect infestations can have a serious impact on your production and your income.

AgriInsurance, also referred to as Production Insurance or Crop Insurance, adds some predictability to your business. It protects you against the effects of yield reductions and crop losses caused by insured naturally occurring perils. Last year there were more than 23,000 acres, 15,644 dairy animals, and 48 million birds insured annually in Nova Scotia.

AgriInsurance helps you:

- Maintain your cash flow in poor crop years with claim payments that offset losses caused by crop damage or low yields.
- Manage your operation with a more predictable cash flow.
- Provide collateral required to secure loans.
- Stabilize your AgriStability program reference margin over time.
- Gain affordable peace-of-mind by paying a tax-deductible premium that is cost-shared with government.

Crop Insurance Application Deadlines for the 2017 Crop Year.

- Vegetable March 14
- Spring Grain March 14
- Acreage Loss (Vegetables) March 31
- Potato April 19
- Corn April 30
- Maple April 30
- Weather Plan April 30
- Soybean (includes Canola and Sunflower) May 19

All producers who hold an active contract of insurance will receive a Coverage Options letter(s) before the beginning of the crop year, for most of the above plans. This gives you an opportunity to choose your price and coverage level options for the upcoming growing season.

Advanced Payments Program

Reminder: If you are planning to apply for an advance through the Advance Payments Program (APP), keep the above application deadlines in mind. In many cases, the APP requires participation in Crop Insurance (or AgriStability) as a security for the advance. Late applications for Crop Insurance cannot be accepted after the above dates.

Dairy Producers

The Commission is able to write new coverage for Dairy Livestock at any time during the year. If you are interested in insuring your animals against disease, as well as loss of income from the sale of milk as a result of disease or fire, and building collapse due to ice and snow, it is not too late to apply for Dairy Insurance (includes all reportable diseases, as well as shipping fever and IBR, but does not include BSE and Foot and Mouth). Wildlife Compensation

The Nova Scotia Crop and Livestock Insurance Commission administers a Wildlife Compensation Program for Nova Scotia farmers who experience losses of animals or crops as a result of uncontrollable wildlife. This program applies to specific livestock as a result of predation by specified wildlife. Similarly, specified crops are eligible for this compensation program. Maple Producers

The Nova Scotia Crop and Livestock **Insurance Commission offers crop** insurance for maple syrup production. This plan is available to all commercial maple producers to help them manage the risk of reduced yields due to natural perils. Any producers not currently signed up in the program can apply now for coverage for the 2017-18 crop year (the Feb-Mar 2018 harvest season). The deadline for application is April 30, 2017. Since April is a busy time in the maple woods, we encourage you to apply now to avoid missing the deadline. Since 2009, the Commission has paid indemnity claims totaling almost \$240,000 to all but one of our insured maple clients, due to adverse weather

Forage Producers

The Commission offers two plans for forage producers to help manage the risk in the crop from natural perils. These plans are a Forage Establishment Plan and a Weather Derivative Plan for forage production.

Forage Establishment Plan

The forage establishment plan protects against establishment failure in the first year of growth for grasses, alfalfa and other legumes. This plan covers losses from such things as winter injury, drought, insects, diseases, floods, excess moisture, frost and wind. The plan covers your new forage crop from the time of seeding up until May 31 of the following year. Seeding must be completed by July 1 for legumes and legume/grass mixes and by September 1 for grasses. The deadline to apply for this insurance is October 15, but you can apply as soon as your crop is seeded. When you apply after your seeding date, an inspection is required before coverage will be offered. This plan offers three levels of coverage which are \$300/acre (producer premium \$9.25/acre) \$200/acre coverage (producer premium - \$6.25/acre) and \$100/acre coverage (producer premium = \$3.25/acre).

Weather Plan for Forage

This plan targets crop losses related to weather events. It guarantees 80% of the average long term rainfall (mm) at a designated local weather station over a period of time (May 1-August 31). An optional Quality Rider is also available for excessive rainfall in the month of June during prime harvest time. Managed pastures and stored forage acreage can be insured. The Weather Derivative Plan for Forage provides a guarantee of 80% of the long term average rainfall (30 year averages). A producer can choose 2, 3 or 4

months of drought coverage between May 1 and August 31. Any or all of the managed forage and/or pasture on your farm can be insured for up to \$288 per acre.

With the Quality Rider, when three consecutive days of rainfall of at least 5mm are recorded, a payment of 20% of your guarantee is triggered. Producers can receive up to two payments under this quality rider during the month of June. For the weather plan, rainfall measurements are based on the recorded rainfall from sites around the province, primarily at Environment Canada weather stations. Producers select the site nearest their farm. This plan differs from other insurance plans since there are no yield measurements required. Once a drought or excess rainfall event occurs, based on Environment Canada weather statistics, a payment is triggered. For more information, including the cost sharing with government for these programs, contact one of our offices.

Have You Reported Your Yield for 2016?

To provide accurate coverage to our clients, the Commission needs your harvested yield report for 2016. If clients do not report their actual yield, the Commission assumes you have harvested at least the guaranteed production listed on you Certificate of Insurance. In years where you had very good production and where you do not report to the Commission, you are missing an opportunity to have this reflected in your yield history. What this means for you is that in a future claim year, your claim may not be as much as it could have been if the good experience was properly reported. To ensure you have the best coverage possible, be sure to accurately report your yields.

New Plan for Vegetable Growers

A new plan called the Crop Insurance Plan for Acreage Loss was offered for the first time in 2016.

This plan differs from the current vegetable plan because it is not based on a guaranteed yield but rather a guarantee value per acre of crop grown. If the crop cannot be harvested because of an insurable peril a payment can be made for the entire acreage lost. Any abandoned acres must be destroyed to obtain a payment.

Next Policy Framework Consultations

Growing Forward 2 comes to an end March 31, 2018. Federal, provincial and territorial governments are currently working together to develop the next agricultural policy (NPF) framework which will launch on April 1, 2018. FPT governments and industry share a collective vision of creating a modern, sustainable and prosperous sector. The Nova Scotia Department of Agriculture (NSDA) will be seeking your feedback on the next suite of programs. NSDA will be holding consultation sessions across the province in the coming months as well as creating an on-line option for submitting your feedback. More detailed information on how to submit your feedback will be made available soon.

The NPF will focus on six priority areas, Markets and Trade; Science, Research and Innovation; Risk Management; Environmental Sustainability and Climate Change; Value Added Agriculture and Agri-Food Processing; and Public Trust. Dr. Laura Ross - Award Winning Pathologist



Perennia's food safety team is offering 20 courses as part of its public training calendar for 2017 – the largest number of courses it has ever offered in one season. All courses are held at the Perennia Innovation Centre in Bible Hill, Nova Scotia. For the complete list or to register, please visit www.perennia.ca/events

BRC Global Standard for Food Issue 7 – Understanding the Requirements – March 28-29, 2017

This course gives technical, quality and operations staff from manufacturers, retailers, and food service companies a clear understanding of the protocols and requirements of the BRC Global Standard for Food Safety, Issue 7, including audit planning and the events during and after the audit.

Before the course you must have read and reviewed a copy of the Standard. At the end of the course you will be assessed by an exam.

Registration deadline: March 14, 2017

BRC: Internal Auditor – March 30-31, 2017

This two-day course will enable you to undertake internal audits and prepare companies for third party audits. It's delivered via a series of workshop-led discussions, presentations and in interactive case study. During the live case study, you will be given feedback and support to enable you to carry out an audit at your own workplace. You will be assessed throughout the course (50%) and you will also need to undertake a workplace audit and submit an audit report for assessment (50%). You will need to gain a 75% pass for this assessment.

Environmental Monitoring and Microbiology – April 10, 2017 Monitoring the food processing environment is of paramount importance for regulatory compliance and to meet the requirements of Global Food Safety Initiative (GFSI) standards.

Individuals responsible for facility environmental monitoring must have a good understanding of the critical areas of manufacturing and should be able to compile and interpret lab results and implement a system in which the results are trended. This one-day training program covers best practices in design of environmental monitoring programs, parameters around testing, sampling methods, data interpretation and environmental indicators.

Listeria Hazard and Control – April 11, 2017

Protect consumers, your product and your business by eliminating and preventing Listeria monocytogenes in your facility. An effective Listeria sampling program will detect Listeria, and outline corrective actions. Understand the nature of the hazard and means for controlling it in order to protect consumer health. In this workshop, you will have the opportunity to develop and improve your Listeria monitoring program.

Meat Cutting Course

Red Meat Cutting Basics will run over 3 days, covering basic cutting and breaking techniques for beef, pork, and lamb. Participants will learn to identify primal, sub-primal and retail cuts, along with their origin, use, relative value, and preparation techniques. They will also learn how to select, use, sharpen and maintain

tools/equipment for boning and cutting, and how to package and display meats using common packaging materials. Regulatory requirements and appropriate procedures for sanitation/meat handling in a functional meat processing facility will be integrated into the training.

March 27-29, 2017- Dalhousie Agricultural Campus

Bulk Milk Graders Course

The course provides the training necessary for both Bulk Milk Tank Drivers and Dairy Receivers to be licensed by the N.S. Department of Agriculture. It is offered over a three-day period with a combination of theoretical and hands-on learning. Participants must achieve a 70% score on both the written and grading exams to receive certification.

May 17 - 19, 2017 - Dalhousie Agricultural Campus

Bulk Milk Refreshers Course

The Bulk Milk Grader Recertification Course provides an opportunity for Certified Drivers and Receivers to update their bulk milk grading skills. Certified Bulk Milk Graders in Nova Scotia are required to re-certify every 5 years. This course is approved by the N.S. Department of Agriculture to meet these criteria.

Pesticides Applicator's Certification

This four-day course is excellent preparation if you are writing the Pesticide Applicator's Examination. You will learn the basic principles and practices of safe use, handling and storage of pesticides. Information is presented about the ground application of pesticides but does not include aerial spraying.

Do You Have the Proper Driver's License?

If you have a farm tractor trailer combination over 14,000 kg, you need a Condition 23 Endorsement and if you are hauling any trailer (with a truck or tractor) that has a weight over 4500kg, you need a Condition 15 Endorsement on your license to legally drive on Nova Scotia roads. These regulations apply to the class 5 license.

You must have a valid driver's license ("N" removed for Condition 23) to be eligible for testing.

Need a Sharps Container?

Livestock producers generate medical waste on a regular basis. These wastes include sharps such as syringes, needles, broken glass tubes, lancets and scalpel blades.

If not disposed of properly they can injure livestock and family members, increase risk of spreading infection, pollute the environment and put waste handlers at risk.

Sharps must not be discarded in regular household garbage. Sharps containers have been specifically designed for disposing of sharps. When the container is full, the contents should still be considered potentially infectious to humans and animals, but the risk is

For disposal in any municipality, you must first check with your local disposal site to see what they have in place to accept sharps.

These containers can be picked up at the Department of Agriculture office in Cornwallis Park. Call 902-638-2395 for hours and information.
